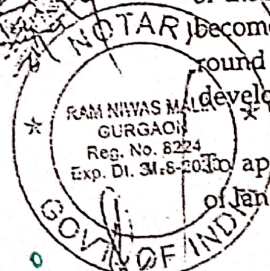
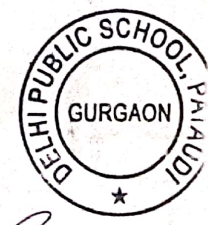


### MEMORANDUM OF THE ASSOCIATION

xxxi. To organize free Medical camps, blood donations, Camps Eye Donation Camps, Etc. in Village and urban areas for the benefit of the general public.

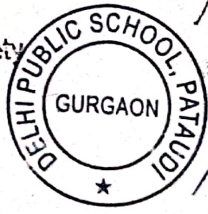
